What is the overall deductible?	For each calendar year, In-network: Tier I Individual \$1,750/Family \$3,500 In-network: Tier II Individual \$2,250/Family \$4,000.	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> and generic <u>prescription drugs</u> are covered before you meet your <u>deductible</u>	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Designated <u>specialties</u> are: cardiology, cardiothoracic surgery, gastroenterology, general surgery, obstetrics and gynecology, orthopedics, otolaryngology, neurology, neurosurgery, plastic surgery, urology and vascular surgery.

All primary care physicians are Tier 1; non-designated **specialists** are Tier 1.

Tier 1 hospitals are Christus, Memorial Hermann, St. Joseph's, CHI St. Luke's, Tenet, and Texas Children's.
